### Annual Enrollment for <u>Pre-Medicare</u> Retirees

October 2023

The following reflects the information AT&T has provided to AASBCR® regarding Annual Enrollment for <u>Pre-Medicare</u> Retirees which begins on October 16th and ends on <u>November 10th</u>. # **Medical Coverage Options**

The following coverage options will continue in 2024:

- High deductible Broad -- Contribution \$100 740
- High deductible Select Contribution \$90 700
- Low deductible Select -- Contributions \$180 1640

If the retiree does not make a selection, they will automatically be placed into the <u>High</u> <u>deductible – Broad</u> coverage option. This option provides coverage both in and out of network.

<u>High deductible -- Select</u> is a subset of High deductible – Broad. The doctor/hospital network is smaller and the plan provides for only in-network coverage. The premiums are lower, and Doctors may provide discounts/pricing different than Broad, but the deductible and maximum out-of-pocket are higher.

<u>Low deductible – Select</u> has higher monthly contributions than High/Select, but the deductible and out-of-pocket maximum are lower.

## New Medical Administrator and Two New Regional Plans

In the Dallas/Fort Worth area and in parts of the East Coast two new medical options are being added with a new Medical Administrator, the **Centivo Care Network**. **Centivo** is a narrower, curated network centered around the **Baylor, Scott & White health** system in DFW. Two options are available on the Centivo network:

- High deductible Care Contributions \$70 -645
- Low deductible Care Contributions \$150 1540

<u>High deductible Care</u> mirrors High deductible Select but is only available in the Dallas Fort Worth area.

Low deductible Care mirrors Low deductible Select and is available in DFW, Northeast, CT, NJ, NY, PA, and the Orlando area

### **Medical Concierge Service**

AT&T will continue to offer the concierge service called "Your Personal Healthcare Team." It will be available to Pre-Medicare retirees enrolled in medical services and will assist in finding a doctor or selecting a healthcare plan, help to resolve billing issues, and enable you to see a doctor 24/7 at no cost to you.

# **Dependent Eligibility**

When one member of a retiree family is Medicare-eligible, it will no longer be required for the retiree to be enrolled in the company-sponsored coverage for the dependents to be eligible for AT&T coverage.

## CarePlus

**Hearing aid** coverage will be removed from CarePlus but remains available in medical services for pre-Medicare retirees with an allowance of \$2000 every 3 years.
